

# PRIVACY POLICY

This Privacy Policy describes how your personal information is collected, used, and shared when you visit from <https://www.funtable.io> (the “Site”).

Protecting your private information is our priority. This Statement of Privacy applies to <https://www.funtable.io> and governs data collection and usage. We have developed this policy in order for you to understand how we collect, use, communicate and make use of personal information. The following outlines our privacy policy.

Similar to other commercial websites, our website utilizes a standard technology called ‘cookies’ (see our cookies policy section for more information) and server logs to collect information about how our site is used. Information gathered through cookies and server logs may include the date and time of visits, the pages viewed, time spent at our site, and the websites visited just before and just after our own, as well as your IP address.

## INTRODUCTION

This Policy sets out the conditions under which we may process any information that we collect from you, or that you provide to us. It covers information that could identify you (“personal information”) and information that could not. In the context of the law and this notice, “process” means collect, store, transfer, use or otherwise act on information.

1. We take seriously the protection of your privacy and confidentiality. We understand that all visitors to our website are entitled to know that their personal data will not be used for any purpose unintended by them, and will not accidentally fall into the hands of a third party.
2. FunTable.io undertakes to preserve the confidentiality of all information you provide to us, and hope that you reciprocate.
3. The law requires us to tell you about your rights and our obligations to you in regards to the processing and control of your personal data.

## LOG FILES

FunTable.io follows a standard procedure of using log files. These files, log visitors when they visit websites. All hosting companies do this and a part of hosting services' analytics. The information collected from log files includes internet protocol (IP) addresses, browser type, Internet Service Provider (ISP), date and time stamp, referring/exit pages, and possibly the number of clicks. These are not linked to any information that is personally identifiable. The purpose of the information is for analyzing trends, administering the site, tracking users' movement on the website, and gathering demographic information.

## COLLECTION OF YOUR PERSONAL INFORMATION

FunTable.io may collect personally identifiable information such as your: Name, and E-mail Address when you register yourself in our website.

## WHAT INFORMATION WE COLLECT AND WHY?

We may collect information about you directly from you, as well as automatically through your use of our Site or Services.

- **Information We Collect Directly from You:** Certain areas and features of our Site and Services require your Name, email address, and IP address.
- **Information We Collect Automatically:** We may automatically collect the following information about your use of our Site via some software analytics including the length of time you visit our Site and your movement through our Site.
- **We may also collect the following information:** device ID; location and language information.

## **WE DO NOT SELL, RENT OR LEASE ITS CUSTOMER LISTS TO THIRD PARTIES.**

FunTable.io may share data with trusted partners to help perform statistical analysis, send you email or postal mail, provide customer support, or arrange for deliveries. All such third parties are prohibited from using your personal information except to provide these services to FunTable.io, and they are required to maintain the confidentiality of your information.

FunTable.io will disclose your personal information, without notice, only if required to do so by law or in the good faith belief that such action is necessary to: (a) Conform to the edicts of the law or comply with legal process served on FunTable.io or the site; (b) protect and defend the rights or property of FunTable.io; And, (c) act under exigent circumstances to protect the personal safety of users of our website, or the public.

## **INFORMATION WE PROCESS BECAUSE WE HAVE A CONTRACTUAL OBLIGATION WITH YOU**

We may use it in order to:

## **COOKIES AND WEB BEACONS**

These cookies are used to store information including visitors' preferences, and the pages on the website that the visitor accessed or visited. The information is used to optimize the users' experience by customizing our web page content based on visitors' browser type and/or other information.

### **THIRD PARTY PRIVACY POLICIES**

### **CHILDREN'S INFORMATION**

## **GENERAL DATA PROTECTION REGULATION (GDPR)**

We are a Data Controller of your information.

Whenever information is transferred between us, you can check that it is done so using SSL by looking for a closed padlock symbol or other trust mark in your browser's URL bar or toolbar.

## **COOKIES POLICY**

Our website uses cookies. They are placed by the software that operates on our servers, and by software operated by third parties whose services we use. Requests by your web browser to our servers for web pages and other content on our website are recorded.

Our website record information such as your geographical location, your Internet service provider and your IP address. We also record information about the software you are using to browse our website, such as the type of computer or device and the screen resolution.

FunTable.io uses this information in aggregate to assess the popularity of the webpages on our website and how we perform in providing content to you.

## **USE OF RE-MARKETING**

Re-marketing involves placing a cookie on your computer when you browse our website in order to be able to serve to you an advert for our services when you visit some other website.
